

SHOW RULES

1. **ELIGIBILITY:** Open to all Colorado artists.
2. **THEME:** Open theme.
3. **SHOW DATES:** Feb. 27-March 30, 2012
4. **WHERE:** Lkwd. Arts Council's
Community Art Center & Gallery
85 S. Union Blvd., Lkwd. 80228-2207
(south of 6th Ave., turn in at Wendys)
5. **MEDIA:** Any fine art medium, including photography, digital, sculpture, pottery, fiber, wood, glass, mosaics.
6. **ENTRIES:** Each artist may submit up to 4 original works (no reproductions from original work).
7. **FEE:** \$7.00 per entry (\$6 LAC members)
Checks payable to Lkwd. Arts Council.
(Fees are non-refundable!)
8. **SPECIFICATIONS:** Works must be originals by the artist. Wall-hung work must be framed or have wrapped, *painted* edges with staples visible only from the back. Works must be dry and ready for hanging with wire (NO SAWTOOTH HANGERS). Entries with broken glass, chipped frames, etc. will be disqualified. Works must be identified on the back with the artists name, phone number, title, medium.
HAVE WORKS READY PRIOR TO DELIVERY.
9. **JURYING:** Works will be juried for acceptance into the show.
Juror CHUCK DANFORD is an award winning watercolor artist who is well-known for his distinctive interpretations of nature. Visit his website at www.charlesdanford.com
10. **AWARDS:** (winners will be notified)
Best of Show: \$100
Second Place: \$ 75
Third Place: \$ 50
Merit Awards: \$ 25 each
11. **SALES:** Works need not be for sale. No commission will be charged on sales. Artists will be notified in the event of a sale.
12. **INSURANCE:** No insurance is provided.

Pick up of unaccepted work. A \$10 per day storage fee will be charged for works not picked up on time.

Thurs, March 1, 6:30-8:00pm

Public Reception & awards.

Fri, March 30, 3-5:00 or Sat, March 31, 10-1:00:

Pick up unsold works. A \$10 per day storage fee will be charged for works not picked up on time.
